

THE CORPORATION OF THE TOWNSHIP OF CHAPLEAU

BY-LAW NO. 2003-08

Being a By-Law for licencing, regulating and governing owners and drivers of taxicabs, motor and other vehicles used for hire and for the conveyance of goods and passengers.

WHEREAS Section 232, Chapter M.45 of the Municipal Act, R.S.O. 1990 as amended, provides that Councils may pass by-laws for licencing, regulating and governing owners and drivers of taxicabs, motor and other vehicles used for hire and for the conveyance of goods and passengers; And

WHEREAS Council deems it necessary and expedient to enact a By-Law for this purpose;

NOW THEREFORE the Council of the Corporation of the Township of Chapleau ENACTS AS FOLLOWS;

1. Whenever used in this By-Law the word:
  - a) ACouncil≡ shall mean the Municipal Council of the Township of Chapleau.
  - b) AMunicipality≡ shall mean the Municipality of the Township of Chapleau.
  - c) ABy-Law Enforcement Officer≡ shall mean the By-Law Enforcement Officer appointed from time to time by the Council of the Township of Chapleau.
  - d) ADriver≡ means a person licensed according to this By-Law who is engaged in driving or operating a taxicab on behalf of himself/herself or another person who is the owner thereof.
  - e) ATaxicab≡ means a motor vehicle as defined in the Highway Traffic Act, R.S.O. 1990, Chapter H.8 as amended, having a seating capacity of not more than six persons, exclusive of the driver, hired for one specific trip for the transportation exclusively of one person or group of persons, one fare or charge only being collected or made for the trip.
  - f) AOwner≡ means any person licensed according to this By-Law who owns a taxicab or has possession or control thereof under an installment purchase agreement or by way of rental.
  - g) APrescribed Tariff≡ means the tariff set out on Schedule AC≡ hereto.
  - h) ATaxicab Broker≡ means a person who accepts calls in any manner for taxicabs that are used for hire and that are owned by persons other than himself/herself, his/her immediate family or his/her employer.
  - i) ALicense≡ means a license granted by the Council under the provisions of this by-law to own (owner=s license), to drive (driver=s license), or to act as a taxicab broker (broker=s license).
2. The By-Law Enforcement Officer shall have supervision over all persons licensed under this By-Law, and over all vehicles in respect of which licenses are issued and shall in connection with this By-Law:

- a) Report to the Council of the performance of his duties at any time upon request of the Council;
- b) Make all necessary and proper inquiries concerning applications for licenses and the suspension, revocation and transfer thereof;
- c) Cause the examination and testing of every applicant for a driver's license as to his/her ability to operate the vehicle to be driven by him/her, if deemed necessary;
- d) Cause the inspection and satisfy himself/herself as to the sufficiency, repair and condition of every vehicle in respect of which a license is applied for according to the terms of this By-Law;
- e) Satisfy himself/herself as to the good character and responsibility of all applicants;
- f) Cause to be made out all licenses and submit to the Council the names of all applicants for licenses a report of the action taken thereto and a report of all matters having to do with the revocation or suspension of any license;
- g) Keep a register of all licenses;
- h) Furnish forms of applicants for licenses;
- i) Upon issuing a license furnish to the licensee one copy of this By-Law and one tariff card containing the tariff herein provided and the By-Law Office may check all taxicabs from time to time to see that the tariff card is displayed in a conspicuous place in the interior of each taxicab;
- j) Prosecute all persons who contravene any provisions of this By-Law.

### INSURANCE

3.
  - a) Every owner, in respect to each taxicab belonging to him/her, shall procure a policy of insurance endorsed to the effect that the Council will be given at least ten days notice, in writing, of any cancellation, expiry or change in the amount of the policy, and deposit a copy or certificate thereof with the Council;
  - b) The said policy of insurance shall insure the owner and driver of such taxicab against loss or damage resulting from bodily injury or death to passengers as well as others and against damage to property to an aggregate maximum limit of not less than one million dollars (\$1,000,000.00) for all claims in any one accident, exclusive of interest and costs and at all times save harmless the Township of Chapleau from any and all claims arising from time to time;
  - c) Every such policy of insurance or certificate thereof shall be deposited with the By-Law Officer before the owner commences operation of the insured vehicle as a taxicab, and shall be kept in

force by such owner during the period for which the license issued to him, or any renewal thereof is in effect and should he/she fail to renew the same from time to time, and to pay premium due thereof to the By-Law Officer, upon notice to the said owner may cancel such license.

#### OWNER=S LICENSE

4. a) No person shall operate a taxicab or permit a taxicab to be operated for hire in the municipality without an owner=s license from the Council and payment to the Corporation of the annual license fee established by Schedule AA≅ of this By-Law.
- b) Every owner of more than one taxicab required to be licensed under this By-Law shall take out a separate license for each taxicab, as provided under Schedule AA≅ hereto.
- c) Every applicant for an owner=s license shall submit each taxicab for a visual inspection prior to issuance of the license therefor.

#### DRIVER=S LICENSE

- 5 a) No person shall drive or operate a taxicab in the municipality without a driver=s license from the Council and payment established by Schedule AA≅ of this By-Law.
  - 1) An application for broker=s, owner=s or driver=s license shall be made to the By-Law Officer on the application forms supplied for such purpose attached hereto as Schedule AB≅. The By-Law Officer shall endorse the report thereon and submit the same to the Council and such driver=s application shall be authorized by a taxicab owner indicating the intention of such owner to permit the applicant to operate that owner=s taxicab.
  - 2) The By-Law Officer is hereby authorized to cause two photographs of the license applicants to be taken and to collect a fee of ten dollars (\$10.00) therefore.
- b) No license shall be granted except upon application therefore by a person who is at least nineteen (19) years of age and of good character, who possesses knowledge of the geography of the municipality and of the prescribed tariff, and
  - 1) Who has supplied two (2) photographs of himself/herself approved by the By-Law Officer **and a Criminal Record Check**. A copy of such a photograph with a description of the person so photographed shall be exhibited in the vehicle in a manner approved by the By-Law Officer and the Council, and
  - 2) In the case of an owner, except upon affidavit that he/she is the registered and true owner of he taxicab.

#### BROKER=S LICENSE

6. a) No taxicab broker shall operate a taxicab stand without a broker=s license from the Council and payment to the Corporation of the annual fee prescribed in Schedule AA≅ hereto.

- b) In this By-Law a taxicab stand includes any place where calls are accepted for taxicabs and may include a public waiting area.
- c) All licenses shall be granted by the Council and issued and signed by the By-Law Officer.

#### TRANSFER OF LICENSE

- 7. No brokers license issued under this By-Law may be transferred from one person to another without the prior written approval of the By-Law Officer, which approval may be withheld at the By-Law Officer=s discretion, unless the transferee is able to fulfill the requirements of this By-Law and pay to the Municipality the fee imposed by Schedule AA≡ of this By-Law on such a transfer.

#### APPEAL

- 8. Any act done by or by authority of the By-Law Officer under any of the provisions of this By-Law shall be subject to the appeal to the Council by any person feeling aggrieved.

#### REVOCACTION OF LICENSE

- 9.
  - a) Licenses may be refused or revoked by the council in its discretion subject to the Statutory Powers Procedure Act.
  - b) In the event of any license being revoked, the previous holder thereof shall not be entitled to a new license unless the Council approved the granting of such new license.
  - c) The By-Law Officer may suspend any license until the next meeting of Council where any apparent contravention of the Criminal Code, or loss of 7 or more points under the Highway Traffic Act or any breach of the Liquor License Act, or of Sections 3, 20, 24, 25, 26, 27 or 31(b) of this By-Law, in the By-Law Officer=s opinion, warrants such suspension provided that the person whose license is suspended is entitled to appeal the suspension at the next meeting of the Council pursuant to the Statutory Powers Procedure Act.

#### OCCUPANCY

- 10. No person shall carry in any vehicle used for hire a greater number of occupants or persons than the manufacturers rating of seating capacity of such vehicle inclusive of the driver.

#### DRIVER=S IDENTIFICATION

- 11.
  - a) Every taxicab driver shall be furnished by the Council with a numbered identification card and shall keep the same affixed to interior of the vehicle so it will be clearly visible at all times when driving a taxicab.
  - b) Every driver of a taxicab shall retain his/her taxicab driver=s license in his/her possession at all time while operating the same, and upon request shall surrender his/her taxicab driver=s license to any police officer.

#### OWNER=S VEHICLE

12. a) Whenever any owner disposes of a taxicab and acquires another in its stead, he/she shall, before using the new taxicab, submit the same to the By-Law Officer for inspection and approval and apply for and obtain a transfer to the owner=s license to cover the newly acquired vehicle.

- b) The holder of an owner=s license or a driver=s license shall not change the place of stand or place of business without prior notice to the By-Law Officer and payment of the fee as outlined in Schedule AA≅ of this By-Law to the Municipality and for the place of a stand, a certificate from the Director of Planning for the Municipality of Chapleau.

#### EXPIRY OF LICENSE

13. Every license, unless sooner revoked, shall expire on the 31st day of December in the year for which it was issued.
  - a) No owner shall employ as a driver of a taxicab any person other than a licensed driver under this By-Law.
  - b) No taxicab broker shall accept calls for any unlicensed owner or driver under this By-Law.

#### NO SMOKING

14. a) No driver shall smoke while driving any passenger or passengers if so requested by a passenger.
  - b) No owner or driver or anyone else with his/her consent shall wash or make repairs to his/her vehicle while upon a public taxicab stand unless such repairs are immediately required and are of a minor nature.

#### NO LIQUOR

15. a) No driver shall take, consume or have in his possession any liquor while he/she is in charge of a taxicab.
  - b) No effects of liquor consumption by a driver shall be apparent while he/she is in charge of a taxicab.

#### TAXI STAND

16. a) No person, while on any taxicab stand, shall in any way obstruct the use of the sidewalk, or make any loud noises or disturbances, or use profane, obscene, impudent or abusive language, or molest, annoy or insult the owner, occupants, inmates or inhabitants of any building or residence or any person whatsoever and shall not while on any such taxicab stand or at any railway station or other public place, place his/her taxicab so as to obstruct traffic in any way.
  - b) Any public waiting area in a taxicab stand shall be maintained in a clean and tidy condition.

#### CHANGE OF ADDRESS

17. a) Every person licensed under this By-Law shall, upon changing his/her

residential address notify the By-Law Office in writing, within two days of such change of address.

- b) Every taxicab broker and owner shall notify the By-Law Officer on or before the 1st day of January, April, July and October of the names, addresses and licence numbers of taxicab drivers currently in his/her employment on forms to be supplied by the By-Law Officer.

- c) Every broker shall supply the By-Law Officer at least once every three months with a list of the properties used for stands by taxicabs in his/her brokerage where such taxicabs may sit to await calls on forms to be supplied by the By-Law Officer.

#### DRIVER=S AND OWNER=S DUTIES

18. Every owner and driver shall:

- a) Punctually keep all his/her appointments and engagements, except for reasons beyond his control;
- b) While on duty, unless his/her taxicab has been previously engaged, shall serve at any specified time whether by day or night, any person who may require his/her taxicab, and unless otherwise prohibited by this By-Law.

#### CARE OF PROPERTY

- 19 a) 1) Every owner or driver employed by his/her shall take due care of all property delivered or entrusted to and accepted by him/her for conveyance or safekeeping.
  - 2) Every driver of a taxicab immediately upon termination of any hiring or engagement, shall visually search his/her taxicab immediately for any property lost or left therein.
  - 3) All property, or money left in a taxicab shall be forthwith delivered to the person owning the same, or if the owner cannot be at once found, then the driver shall notify the By-Law Officer with the information in his/her possession regarding the same and the article shall be delivered to the broker immediately for safekeeping for not more than ten (10) days, thence to be delivered to the By-Law Officer by the broker.
- b) No owner or driver shall knowingly:
    - 1) Frequent any disorderly house as defined by the Criminal Code, or
    - 2) Frequent any place where liquor is illegally kept for sale, or
    - 3) Permit his/her taxicab to be used by persons desirous of visiting such places.
  - c) Unless the Council rules otherwise, no person who has been convicted of any criminal offense or of any breach of the Liquor Control Act or whose driving record is deemed by the By-Law Officer unacceptable, shall be granted a license.

- d) No owner or driver shall induce any person to engage him either by knowingly, wantonly, or wilfully misinforming, misleading or deceiving such person as to
  - 1) The time or place of the arrival, of departure of any railroad train, bus, aircraft or other public conveyance, or

- 2) The location or distance from any part of the Municipality of any railway station, airport, hotel, public house or private residence.
  - 3) Nor shall he/she, in any way, manner, or form, impose upon or deceive or in any way insult, abuse or ill treat any person engaging him/her.
- e). No driver shall permit or allow any person to be on any exterior portion of any taxicab while the same is in motion.

#### NO STANDING

- 20. No owner or driver shall permit a taxicab to remain standing on a highway in the Township of Chapleau during the hours of 9:00 am to 6:00 pm, Monday to Saturday inclusive, unless for the purpose of:
  - a) Taking on a passenger who has already engaged the taxicab.
  - b) Discharging a passenger from the taxicab.
  - c) Under direction to remain by a passenger by whom the taxicab is already engaged and in the continuance of such engagements.

#### PASSENGER ADDRESS

- 21. Every owner or driver shall give full information to any Peace Officer on being required to do so, with reference to the address of the house or place to or from which he/she has driven any passenger with his/her description, name and address, if known to him/her.

#### GOOD REPAIR

- 22.
  - a) The owner or driver of every taxicab shall keep the interior clean and dry and the exterior of such taxicab, clean and in good repair.
  - b) Whenever the owner or driver of a taxicab receives a notice signed by the By-Law Officer that such taxicab is not in the fit or proper condition, for use, stating briefly the items complained or, such owner, or driver shall, within the time mentioned in such notice, put the taxicabs in a fit and proper condition.

#### INSPECTION

- 23 a)
  - 1) The owner of every taxicab shall, when required by an Officer, submit his/her taxicab to appear at a Ministry of Transportation and Communications ASafety Lane.
  - 2) No owner or driver shall, at any time, when his/her taxicab is not employed, prevent or hinder the said By-Law Officer or any authorized officer from entering the same or at any time prevent or hinder him/her

from entering a garage or other building for the purpose of inspecting the same.

- 3) The owner of every taxicab, which is more than two (2) years old, shall supply a mechanical fitness certificate in the form required by the Highway Traffic Act at the time of application for each owner's vehicle license or renewal thereof except where such certificate has been provided within the terms of this By-Law within the six months previous to such application.

- 4) Upon notice by registered mail to the owner of a vehicle, such owner shall submit his/her vehicle to appear at the a Ministry of Transportation and Communications ASafety Lane≡ at the time and place designated in such notice.
  - b) No driver of a taxicab shall carry any passenger other than a paying passenger while such vehicle is being used as a taxicab or while on duty subject to calls.
  - c) No driver of any taxicab shall carry any passenger who is under the influence of liquor or any narcotic drug while transporting another passenger or passengers not in the same party.

#### TRIP RECORDS

24.
  - a) Every taxicab owner and every taxicab broker shall keep a record of the date, time, origin and destination of each trip, the name of the driver and the number of the taxicab.
  - b) The trip records shall be retained for at least twelve months at the stand from which the taxicab operates and shall be surrendered immediately for examination when requested by any Officer of the Municipality.

#### FLAT FARES

25. Each taxi broker/owner may at his/her discretion choose as a fare charge regulator either flat rate fares or a taxi meter to compute fares:
  - a) Flat rate fares shall be charged in accordance with Schedule AC≡ attached hereto;
  - b) All flat rates fares are to receive the approval of the Council of the Township of Chapleau before being implemented. Any adjustments to the flat fare rates are to receive the approval the Council of the Township of Chapleau prior to being applied.

#### TAXI METER FARES

26. Every owner may affix to each taxicab in respect to which he/she is licensed, a taximeter which shall register distances traveled and computed fares to be paid and every such taximeter shall be:
  - a) Submitted when required for testing, inspection and sealing by the By-Law Officer;
  - b) Illuminated between dusk and dawn;
  - c) Attached to the taxicab in a location and manner approved by the By-Law Officer;

- d) Adjusted in accordance with the tariff prescribed by Schedule AC≅ of this By-Law;
- e) Tested by running the taxicab to which it is attached over a measured track or distance before being sealed;
- f) Used only when the seal thereon is intact or after due notice has been given to the By-Law Officer and authority has been obtained to operate until the taximeter has been resealed;
- g) Used for not longer than six months without retesting and resealing;
- h) Keep in good working condition at all times and not used when defective in any way;
- i) Not be used until approved by the By-Law Officer.
- j) If a call extends beyond the limits of the Corporation the driver and passenger may agree before the start of the trip to a flat rate but the taximeter must be in a recording position at all times within the limits of the Corporation.
- k) At the conclusion of a trip, the driver shall call the passenger=s attention to the amount of the fare registered on the taximeter and place the taximeter in a non-recording position.

#### FARES

- 27 a) 1) the rates or fares to be charged by every owner and driver shall be exactly as shown in Schedule AC≅ of this By-Law.
- 2) No higher or lower amount than that contained in Schedule AC≅ shall be charged or payable.
- b) When operating on a taximeter basis, the rate of fare charged shall be exactly as shown on the taximeter together with any additional charges authorized by Schedule AC≅ hereto.
- c) 1) No owner or driver or broker shall publish or use a tariff or demand or receive rates and charges other than those authorized by the is By-Law whether such rates and charges are determined by distance or by time.
- 2) Every owner and driver shall keep the tariff card containing the tariff herein provided displayed in a conspicuous place in the interior of each taxicab.
- d) No owner or driver shall be entitled to recover or receive any fare or charge from any person or persons
  - 1) From whom he/she shall have demanded any fare or charge greater or less than those authorized by this By-Law; or
  - 2) To whom he/she has refused to show his/her card or tariff as provided by this By-Law.
- e) 1) When a passenger first enters a taxicab the taximeter shall immediately be placed in a recording position and shall remain so throughout the

trip.

- 2) the shortest possible route shall be taken to the destination desired unless the passenger designates another route.

NO CHARGE

- 28 a) No owner or driver shall make any charge under this By-Law for:
- 1) Time lost through defects of inefficiency of the taxicab, or
  - 2) The incompetency of the driver therefore, or
  - 3) For time consumed by the arrival of the taxicab in response to a call in advance of the time such taxicab has been requested by the person calling same.
- b)
- 1) The tariff or rates herein authorized shall be computed from the time or place when or to which the passenger or passengers first enter the taxicab to the time or place when or at which the passenger or passengers finally discharge the taxicab.
  - 2) The owner of every taxicab, shall, as a condition of the receipt of a license, install on the roof of every taxicab belonging to him, an illuminated sign bearing the name of the taxi stand from where the said taxicab operates.
  - 3) The roof sign of every taxicab shall be connected to the taxicab meter whereby the light on the roof sign shall be caused to go out when the taximeter is in a recording position.

TARIFF CARDS

- 29 a) Tariff cards or badges defaced, lost or destroyed, may be replaced by the Council upon the original tariff card or badge being satisfactorily accounted for, and, in the case of a badge, upon payment of an amount fixed by the Council.
- b) Every driver and every owner:
- 1) If driving his/her own taxicab, shall be properly dressed, neat and clean in his/her person, and be civil and well behaved.
  - 2) While on duty at any public taxicab stand shall sit or stand sufficiently close to his/her taxicab as to have it constantly under close supervision, and
  - 3) Such drivers or owners shall not stand in groups of three or more, or in any way obstruct the use of the sidewalk, or make any loud noise or disturbance.
- c) The Council or a person designated thereby may at any time require any person licensed under this By-Law to take a medical examination.

I.D. CARD

30. a) Every taxicab owner and driver, when operating a taxicab, shall have displayed in the vehicle an identification card supplied by the By-Law Office

- b) The identification card will contain the name and description of the driver along with one of the photographs required by section 6 of this By-Law.
- c) The said card will be displayed in a conspicuous place visible to passengers in the vehicle.
- d) the driver shall not display any card except his/her own.

CITY PROPERTY

- 31. a) No person shall park or stand a taxicab on property owned by the Township, other than a highway, within 30 meters of a taxicab stand.
- b) No person shall park or stand a taxicab on property owned by the Corporation for the purpose of soliciting a ride or a fare.

ZONING CERTIFICATE

- 32. The applicant for a license shall supply a certificate from the Director of Planning of the Township of Chapleau that the property to be used for a taxicab stand complies with the Zoning By-Law currently in force in the Township of Chapleau.

PENALTY

- 33. Every person who contravenes any provision of this by-law is guilty of an offence and on conviction is liable to a fine as provided for in the Provincial Offences Act.

DEFICIENCIES

- 34. a) A copy of any deficiency notice given to an owner shall be sent by registered mail to all taxicab brokers.
- b) No taxicab broker shall permit a taxicab owner to operate a taxicab in respect of which a deficiency notice has been sent after the time allowed to repair the deficiencies has expired unless the required repairs have been made.
- 35. That By-Law 2000-01 be and is hereby repealed in its entirety.
- 36. That this By-Law shall come into force and take effect on the 10th day of March, 2003.

READ a FIRST TIME, SECOND and THIRD TIME and FINALLY PASSED this 10th day of March, 2003.
